IN ADDITION, SEALASKA CORPORATION ESTIMATES THAT IT WILL HAVE NO EARNINGS AND PROFITS AS DESCRIBED IN IRC § 316(a)(2) FOR THE 2013 TAXABLE YEAR. ACCORDINGLY, SEALASKA CORPORATION BELIEVES THE PER SHARE DISTRIBUTIONS OF \$1.54 ON APRIL 12, 2013 ARE NOT TAXABLE DIVIDENDS AND HOLDERS OF THOSE SHARES MUST THEREFORE DETERMINE IF THE DISTRIBUTION IS A NONTAXABLE RETURN OF BASIS UNDER IRC § 301(c)(2) OR IF THE DISTRIBUTION IS REPORTED AS A CAPITAL GAIN UNDER IRC § 301(c)(3).**
